APPLICATION PROCESS: WHAT HAPPENS NEXT

You will receive an acknowledgement in the post by return. This will inform you of your allocated Application Number, (please quote this on any future correspondence), along with your Area Team Contact/Telephone Number.

By return you will be supplied with a Reference Number and a suitable contact number. Use this to arrange with our electrical sub-contractor a convenient time to inspect the works. Any defective work will be communicated to your electrical installer and will need to be corrected in order to receive the necessary certification. Once the work is accepted our contractor will notify us and a Building Regulations Completion Certificate will be issued.

Two inspections will normally be required, one at first fix (i.e. pre-plaster) and a second at completion.
